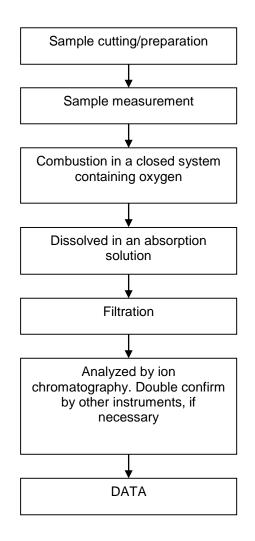

#### **Halogen Testing Flow Chart**




